Fund Description

The SoFi Be Your Own Boss ETF seeks long-term capital appreciation by providing exposure to companies involved in the revolutionary shift towards flexible work through a free market system of freelancers and shared resources that ultimately empower solo entrepreneurs to be their own boss.

- **Thematically-focused** - BYOB is the first ETF to concentrate specifically in this new and exciting sector and provides access to companies involved in the flexible work economy.
- **Globally diversified** – The flexible work economy is global, which is why approximately 40 to 50% of BYOB's holdings consist of companies outside the United States.
- **Actively managed** - Unlike passively managed ETFs, actively managed ETFs like BYOB are capable of quickly responding to changing market conditions. This includes quickly accessing hot tech IPOs (Initial Public Offerings).
- **Designed with SoFi investors in mind** – SoFi ETFs target a higher risk-return profile, suitable for long-term investors who are both beginning their investment journeys and well on their way.

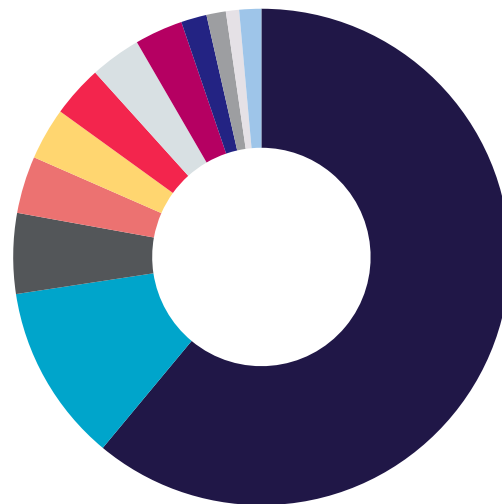
