## Fund Description

The SoFi Select 500 ETF seeks to track the performance, before fees and expenses, of the Solactive SoFi US 500 Growth Index. The SoFi Select 500 ETF seeks to provide exposure to the 500 largest publicly-traded U.S. companies as measured by market capitalization.

- **Low Cost** – Pay no management fees for at least the first year of the ETF’s launch.<sup>1</sup>
- **Low Price Per Share** – Invest with small amounts of money in an ETF with one of the lowest prices per share on the market.
- **Diversified** – Help manage risk by investing in 500 of the largest U.S. companies.
- **Growth-focused** – SFY uses a composite growth score to adjust companies’ weightings in the ETF. The score takes into account sales growth, revenue growth, and forward-looking revenue estimates. Companies with stronger growth characteristics receive a higher weight.
- **Designed with SoFi investors in mind** – SoFi ETFs target a higher risk-return profile, suitable for long-term investors who are both beginning their investment journeys and well on their way.
